6. REPORTS

6.1.CASPN Nurse Administrator

- 6.1.1. Ms. Hacker stated Class 126 students are currently at clinical sites.
- 6.1.2. Ms. Hacker explained Class 127, which begins in August 2020, currently has 60 students. The class will be capped at this number due to social distancing requirements.
- 6.1.3. Ms. Hacker announced 52 students from Class 125 have taken their NCLEX certification exam and 19 have passed already.
- 6.1.4. Ms. Hacker stated that laptops have been ordered for remote learning.
- 6.1.5. Ms. Hacker presented the CASPN Plan to Return to School.

6.2.Principal

- 6.2.1. Mr. Aymer explained there are several ideas for how school will look in the fall. The morning could be different from the afternoon. He will be working with the school principals to create a plan that works best for each district.
- 6.2.2. Mr. Aymer stated he has concerns regarding classes that require a clinical component such as CNA and EMS.

6.3.Director

- 6.3.1. Ms. Ferriell stated that she had a meeting with Area Vocational Directors this morning. She said there were several different plans discussed on how to approach vocational classes this fall.
- 6.3.2. Ms. Ferriell provided an update on capital projects. In the cosmetology area, the flooring, drywall, and painting are finished. Equipment will be installed next week. The parking lot/ring road project is currently underway.
- 6.3.3. Ms. Ferriell presented two bids for fencing in the Early Childhood area. They are from Goodman Fence and Amco Fence Company. Ms. Ferriell recommends Goodman Fence as they submitted the lowest bid.
- 6.3.4. Ms. Ferriell presented two bids for replacing 18 windows throughout the building. They are from Gardner Glass and Bacon & VanBuskirk. Ms. Ferriell recommends Gardner Glass as they submitted the lowest bid.
